Annual dues for new members are prorated based on the month in which the Board of Directors accepts your application. Each member must complete an application form—for example, a husband completes a form and the wife completes one as well.

**Class I—Senior Member:** must be at least 35 years of age by January 1 of the year of application, will have full voting rights, and will have the privilege of holding an office or serving on the Board of Directors. This membership category includes children 12 years or younger who are dependents of the senior member.

**Class II—Intermediate Member:** must be between the ages of 21 and 34 by January 1 of the year of application, will have full voting rights, and will have the privilege of holding an office or serving on the Board of Directors. This membership category includes children 12 years or younger who are dependents of the intermediate member.

**Class III—Junior Member:** must be between the ages of 12 and 20 by January 1 of the year of application. Juniors may not hold any offices or serve on the Board of Directors.

**Class IV—Nonresident Member:** must have a permanent residence outside Putnam County and be 21 or older. A nonresident member may elect to become an intermediate or senior member depending on the member's age, by paying the appropriate dues and fees of that class of membership and still live outside Putnam County. Nonresident members may attend Club functions, but may not vote or hold any office in the club.

**Class V—Business Membership:** must be the chief executive officer of the business. The membership belongs to the business, not to an individual, which means no voting privileges for this class of membership. A business member may purchase and display the club burgee and advertise its organization to the Palatka Yacht Club without additional charge.
